

RESERVATION AGREEMENT / CAMPSITE

- 1 – Fill out **one reservation form for each space.**
- 2 – To secure your reservation, please return **two copies of this filled and signed agreement, as well as 150 €** (including a down payment of **130 €** + a non-reimbursable **20€** (reservation fee) **as soon as possible**). As soon as we receive your mailing, we will send a confirmation and your copy of the agreement.
- 3 – Lots are assigned according to reservation order.
- 4 – You must reserve for a minimum stay of 7 days.
- 5 – You must specify precisely which dates you wish to reserve.
- 6 – Once you have made the reservation, we cannot guarantee you the same spot if you request a change.
- 7 – Each reserved day must be paid. We cannot offer discounts for late arrivals or early departures.
- 8 – Your spot will be available at noon on the day you arrive ; it must be vacated by noon, at the latest, on the day you leave.

RENTAL AGREEMENT / MOBILHOME / CHALETS

- 1 – Fill out **one reservation form for each accomodation.**
- 2 – Rental periods run from Saturday 4 p.m. to Saturday 10 a.m. (*Changes are possible in May, June and September, depending on availability.*) **Please ask us.**
- 3 – Your reservation will be valid once we receive **2 copies of this completed and signed agreement, as well as a down payment equal to 30% of the stay's total fee + a non reimbursable 20€ reservation fee. (+ evtl. coast of cancellation insurance).**
- 4 – We will send you a confirmation and your copy of the agreement.
- 5 – **You must pay the remaining amount of your rental fee upon your arrival.** We cannot offer discounts for late arrivals or early departures. If you purchase the cancellation insurance, the balance of the money owed for the stay must be paid a month before arrival.
- 6 – **Two deposits** must be paid by credit card on arrival ; they will be returned within the week following departure (150 € for Mobilhome or Chalet and 40€ for endly cleaning).
Any damages will be repaired, and the cost of the repair will be taken from the safety deposit. Missing dishes will be replaced at the renter's expenses. Lodgings must be left clean upon departure, otherwise the 40€ deposit will be kept.

GENERAL CONDITIONS

1 – DELAYS

Your reservation will be automatically canceled after an unexplained delay of 24 hours. In that case, we will keep the down payment.

2 – ABSENCE

Days of absence during your stay are not deductible.

3 – CANCELLATION

Send your request for a cancellation in writing :

For the campsite	30 days	}	before the beginning of your stay
For the accomodation	60 days		

In that case, your down payment will be returned to you, minus the reservation fee : 20 €.

4 – INSURANCE

It is the responsibility of campers and renters to insure themselves against cancellation, theft or loss of personal property. The campsite cannot be held responsible.

6 - CANCELLATION INSURANCE

We can subscribe for you a cancellation insurance through "Mondial Assurance"; cost : about 4% of the total amount of the stay, to be paid upon purchase, you must include the full name of all the people who will occupy the lodgings.

5 – RULES

- Tents are not allowed in the Bungalow area.
- Dogs must be kept on a leash everywhere in the camping, Bungalow and beach areas.
Forbidden: 1st and 2nd Category dogs (Pitbull, Rottweiler ...)
- All the campers and renters must follow the rules posted at the entrance.
- Management can ban any person who would break the rules (such intoxication, damage to the property, excessive noise, etc...)

In case of litigation, the Bastia court has jurisdiction.
